**Invitation:**

The Grand CraftFest cordially invites you to participate in an arts & crafts show to be held Saturday, August 7<sup>th</sup> and Sunday, August 8<sup>th</sup>. This friendly outdoor show is a juried exhibition and sale of arts and crafts representing participants throughout Colorado and neighboring states. It will be held in the Grand Lake Town Park as a fundraising activity of the Grand Lake Metropolitan Recreation District (GLMRD) in support of its youth programs in Grand Lake.

**Eligibility:**

The show and sale is open to traditional artists and craft persons who exhibit work of their own concept, design and execution in a variety of media. Products are reviewed to ensure the overall quality and balance of the exhibit. Imported, commercial items, or kits will not be considered or permitted. Misrepresentation at any level will be grounds for removal from this show. Individual participants must be present in their booth on August 7<sup>th</sup> & August 8<sup>th</sup>. Only 35 entries will be accepted. Participants are asked to donate one product item to support a silent auction fundraising event for the youth programs at a later date. The product donations will be collected during the weekend of participation in the Grand CraftFest.

**Photos/Slides:**

Please submit four (4) photos or slides of merchandise for show and sale. Label them with your name and identify the top and front of slides. These are the determining factor in the application process. Be sure to take care that they represent your work fairly and accurately. Please include the price range.

**Selection & Notification:**

All entries must comply with the rules and regulations outlined herein. Entries will be considered solely on the merits of work pictured in submitted photos/slides. If you were a participant in the 2009 show, you will automatically be accepted based on the date your application was received and photos/slides do not need to be sent with your application. All requested items must be included with your application to be considered for this show. Notification acceptance / rejection will be mailed or emailed by July 2, 2010.

**Fees: Please make checks to - GLMRD**

- Booth fee: \$150 per space. (\$15 of your booth fee will be paid to the Town of Grand Lake to cover the Peddler License Fee.)
- If not accepted to the show the booth fee will be refunded along with submitted photos/slides when a self-addressed stamped envelope showing correct postage is included with the application.
- No commission on sales is charged.

### **Exhibit Space:**

A 10x10 space will be provided along the boardwalks in the Town Park. Booths are to be placed directly adjacent to the boardwalk so the general public traffic patterns stays on the boardwalk and does not impact the grass except within the booth space. Artists assume full responsibility for design and construction of the booth. The display must fit within the limits of the assigned space. **NO STAKES MAY BE USED TO SECURE TENTS.** Please be conscious of an underground sprinkling system. There is no electricity available. Suitable protection from sun, wind and rain is suggested. Plastic is suggested to cover displays in case of rain. There is no rain date. Double space may be purchased, if available. All booths are to remain open and attended by the artist during festival hours unless otherwise notified by the committee. The booth fee includes nighttime security on Saturday, August 7<sup>th</sup>, however, leaving valuables inside your space is not recommended.

### **Sales Tax:**

Sales tax collection is the responsibility of each exhibitor. Please collect and forward these taxes to the Colorado Department of Revenue.

### **Information:**

A show packet will be available at registration on the morning of Saturday, August 7<sup>th</sup>, It will include tour booth assignment and map of locations; where to park; and other area information. **NO** pets are allowed in booth spaces.
