**Resident Requirements**

To be entitled to receive an in-district pass, an individual must have established their residency through one or more of the following ways.

1. Currently own property within the district for at least 30 days.
2. Be a registered voter in the district for 30 days.
3. Reside in the district full time for at least 3 consecutive months within the previous 12 months.

**Refund Policy**

Requests for golf pass refunds must be made during the same year in which the golf pass was purchased. Refunds will be based on the amount of use and refunded in the same currency it was purchased. Staff will analyze what is most economical for the purchaser whether Grand Players Pass and the per round cost for the pass and green fees or retail rate would apply. A partial refund will be issued based on the above criteria. If no rounds were played then a full refund will be issued. Each case will be reviewed by staff and refunds will be considered for medical reasons only.
